Sl. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 38 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 7 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
Sl. No.	CONDITIONS FOR COMPLIANCE
1	1. The total number of sections of the school shall be restricted to 38 as per the number of sections reported during inspection, of which not more than 1/3rd sections may be used for senior secondary classes and further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of >500 ft dimension.
2	2. All the three science labs are under equipped.No composite lab, which is mandatory for secondary level students is seen.The school shall upgrade all the science labs as per SoPs of the Board and submit compliance within 3 months on SARAS.
3	3. The school affix a hand rail along the ramp at the entrance of the building. it shall ensure that all CWSN toilets are marked with proper permanent signage, indicating the floor number. The school shall construct seperators between the urinals in the boys' GD Goenka International School KP-V, Greater Noida

	washrooms. The school shall submit compliance on the above points within 3 months on SARAS.
4	4. The school library is seen as under stocked.No reading area for teachers is seen. More indoor and outdoor sports activities can be introduced for students. The school shall upgrade its library and sports facilities as per SoPs of the Board and submit compliance within 3 months.
5	5. The school shall conduct training of its teachers with CoE Noida within 3 months and submit the compliance.
6	6. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
7	7. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time

The above sanction is subject to fulfillment of following conditions:-
